## FIELD TRIPS

The field trips are designed to complement a particular lecture in the lecture series and are held in the week following that lecture. Tickets for field trips are available only to lecture-series ticket-holders. Registration is limited by capacity of busses and places to be visited. Each trip is offered on two dates—please indicate preferred date. The cost of luncheons, ranging from \$1.50 to \$3.50, is not included in the tour price. Such costs will be collected on the day of the trip. There are no refunds on field-trip tickets. When possible, exchanges may be arranged with other subscribers at the lecture preceding each tour. A complete schedule and description of field trips will be mailed to all ticket-holders. In general, trip schedule is 9:00 A.M. to 3:30 P.M.

Sept. 26 (Tues.)  
27 (Wed.)

9:00 A.M. Assemble at 64 East Lake Street. The tour will proceed by bus to Meigs Field and then to McCormick Place for a short lecture on the history and operation of the exposition hall, followed by a "behind the scenes" tour including the art gallery and the kitchens. The group will then go by bus to Carson Pirie Scott and Company for luncheon at Heather House (\$2.25), followed by a brief tour of their British Import Show. In the afternoon the group will proceed to the old Auditorium theater, then to the Pick-Congress Hotel to view the renovation of one of Chicago's oldest home-owned hostels, as well as the management and internal operation of a large metropolitan hotel.

8:45 A.M. Assemble at 64 East Lake Street. The tour will proceed by bus to Navy Pier for a walk along the new observation deck overlooking the cargo loading and unloading dock. Busses will then take the group to Calumet Harbor, where luncheon will be served at The Dorchester Club (\$2.55) in the Harbor vicinity. The tour will then inspect the handling of imports and exports on the docks and warehouses, the loading operations at the grain elevator, and the construction in progress for the new anchor basin. Return to 64 East Lake Street.

8:45 A.M. Assemble at 64 East Lake Street in Room 201 for a short lecture by St. Clair Drake, Professor of Sociology, Roosevelt University. A bus tour of neighborhoods of new residents will be given under the guidance of Mrs. Margaret S. Madden of The Mayor's Commission on Human Relations. Luncheon will be served at the Germania Club (\$2.00). The afternoon will include a visit to the W. C. Goudy School, where the principal will speak to the group; and a tour of The McCormick Boys Club conducted by the Director. Return to 64 East Lake Street.

9:00 A.M. Assemble at 116 South Michigan Avenue, in the Woodrow Wilson Room (2d floor) to meet representatives of The Chicago Council on Foreign Relations, the International Hospitality Center of Chicago, the Institute of International Education, and the Experiment in International Living. The group will then proceed by bus to two centers for foreign students at the University of Chicago. Luncheon will be served at International House, with foreign students as guests, and a tour of the House will follow. The group will then assemble in the Moot Court Room of the new University of Chicago Law School building to hear representatives of some agencies housed at The Public Administration Clearing House describe their work with foreign governmental representatives. Tea will be served November 7 at the Alliance Française, with M. Jean Beliard, French Consul General as special guest; and November 8 at The English Speaking Union, with Kenneth Luke of the British Embassy, Washington, D.C., as special guest. Return to 64 East Lake Street.

8:45 A.M. Assemble at 64 East Lake Street in Room 201 to view a short imported art film presented by Mr. Robin Pearce, Director of the Fine Arts Program at University College. The tour will then proceed by bus to The Harris Bank and Trust Company where the group will see an example of the new international style of architecture grafted onto an old building. Following a visit to the offices of Dave Chapman, Inc., leading industrial designers, the group will go to the Merchandise Mart to view the show rooms of Herman Miller and Knoll Associates. Luncheon will be served at the Merchants and Manufacturers Club (52-20) Business Building.

It offers credit courses in more than forty fields and special non-credit programs of liberal and professional education. Among the latter are the Basic Program of Liberal Education for Adults, the Fine Arts Program, the Center for Programs in the Mass Media, the Center for Programs in Government Administration, the Office of Special Services to Business and Industry, and a series of Special Courses, including seminars, workshops, and tours. All these programs are described in detail in the new 1961-62 Annual Prospectus catalogue, which is available on request from the Downtown Center, 64 East Lake Street, Financial 6-8300.

THE WOMAN'S COLLEGE BOARD of Chicago, established in 1933, is a non-profit organization serving thirty liberal arts colleges and their local alumnae. It is a co-sponsor of the "Know Your Chicago" series, an associate member of the Chicago Educational Television Association, and a sponsor of radio programs by member colleges. Other services include free college counseling for high school girls and publication of an Alumnae Club Guide and a Handbook of Information about member colleges.
